NOTICE OF TRANSFER DATE AND TERMINATION OF CLASSIMEMBERSHIP FOR ELLIOTT RANCH HOMEOWNERS ASSOCIATION, INC.

<u>Document reference</u>. Reference is hereby made to that certain <u>Amended and Restated Declaration of Covenants and Restrictions for Elliott Ranch</u>, filed at Volume 1512, Page 913 (as Document No. 9905970) in the Official Public Records of Hays County, Texas (together with all amendments and supplements filed of record, the "Declaration").

WHEREAS the Declaration governs and restricts the use of lots and common area located within the Elliott Ranch subdivision;

WHEREAS the Declaration provides that owners of lots subject to the Declaration shall automatically be members of Elliott Ranch Homeowners Association, Inc. (the "Association");

WHEREAS Article 11, sub-article (c)(ii) of the Declaration provides that the individual or entity holding Declarant rights under the Declaration shall hold Class B membership rights in the Association until December 31, 2011, or such earlier date as the Declarant elects to terminate its Class B membership (said date being defined in the Declaration as the "Transfer Date");

WHEREAS the undersigned currently holds all Declarant rights under the Declaration and desires to terminate its Class B membership;

THEREFORE notice is hereby provided that:

- The Declarant has, and by means of this instrument does, terminate its Class B membership rights in the Association;
- 2. The Transfer Date is the date that this instrument is executed; and
- 3. As a result of the passage of the Transfer Date, the Association is now vested with additional powers and authority as further provided in the Declaration, including but not limited to the authority of the board of directors of the Association to appoint members of the Architectural Control Committee (see Declaration, Article 4, sub-article (a)) and to amend or grant certain utility and drainage easements (see Declaration, Article 7, sub-article (a)).
